THE ATTRACTIVE NUISANCE

The President's Message

It would never occur to some of us to arrive at home after a long day of dealing with joint tenancy agreements and the evaluation of prescriptive easement rights only to snuggle up on the couch with a novel about the legal


profession. But sometimes, and I mean literally only once amid maybe twenty other choices, I find that I do precisely that. For this reason, I took notice recently when the ABA journal released its list of the 25 greatest law novels of all time.

The list opens with Jane Gardam's Old Filth. No one could ignore Ms. Gardam's ethereal writerly gifts; her prose

m a s s a g e s t h e m i n d i n a n extraordinarily pleasurable way even as the novel launches into a depressing indictment of the legal profession through a detailed portrayal of the dark end result of a man's decision to devote his life to the practice. Lost and broken, the protagonist makes desperate attempts to connect on a personal level with a series of people from his past, but inevitably resigns himself to miserable failure. As awful as all of this might sound, the thing is

an absolute masterpiece. It just surprises me that the ABA would select such a book as the face of the list, the title all readers see first. Perhaps they think of it simplistically as some kind of cautionary tale about work-life

balance.



Defense were it a novel.

But among these kinds of nonsurprises are some great classics about which many may have forgotten, including Alexandre Dumas' <u>The</u> <u>Count of Monte Cristo</u>. If you ever need a story to remind you of the law's context among, say, long-established systems governing social class, economics, and political power, look no further. I find <u>The Count of Monte</u> <u>Cristo</u> to be the ultimate revenge story, but the supreme irony is how "Monte Cristo" tries to achieve this revenge.

And of course <u>The Handmaid's Tale</u> by Margaret Atwood rightfully has a place on the list, though many would not classify it as a law novel. While critics often dismiss it as feminist propaganda, a careful reading reveals a nuanced dystopia, a world scary even for men, that could be created with a few constitutional tweaks here and there. I can understand why the ABA would want on the list a book like this to underscore the importance of our foundational legal documents.

But more broadly, I'm pleased that the ABA would release such a list because it demonstrates an awareness of context, an acknowledgment that the legal profession does not operate in a vacuum, but amidst a thriving culture, and that those of us within it should be more aware of what attention it receives in that culture. Personally, I like to be familiar not only with these kinds of novels, but also the with movies and television shows where most people get their ideas about what goes on in the legal world. At the very least, such awareness is valuable because it makes us remember the origins of the profession and think about what we do now. With it, we can consider how our own practices impact these trends on a daily basis and whether this impact is what we want it to be or not.

State Bar Trustee's Report

Access to Justice Commission

The Montana "access to justice" concept of addressing the legal needs of those unable to afford attorneys has a rocky history. The efforts have been addressed by multiple agencies, committees, by Montana Legal Services Association, the Montana Justice Foundation and many others. The "self-help" clinics and program, if anything, increased the numbers of pro se litigants. The "unbundled legal service", a fancy term for limited scope representation has an undemonstrated affect. The Supreme Court sought a comprehensive review of all such services and recommendations for state-wide, coordinated efforts. Unfortunately, the Access to Justice Commission itself suffered from organizational difficulty and was itself "unfunded." The Commission formed various subcommittees, including a strategic planning subcommittee. Recently, (1) Justice Beth Baker assumed the full Commission's chair, (2) the Office of Supreme Court Administrator agreed to provide website and document storage support and (3) an additional Montana Justice Foundation grant and MJF will provide continued administrative support. (4) Janice Doggett of the State Bar will continue to provide some staff support. I'll serve one more year as the Bar's representative. One and a half years after the court's order forming the commission, I am hopeful it can begin its work. Getting a handle on Montana's low income citizens' legal needs is a daunting, but necessary task.

Legal Research Task Force

I chaired this committee which invited various providers of online legal research to submit bids to the Bar Association for state-wide, Bar sponsored program. Approximately 35 other State Bars presently provide no-cost legal research to their members. Unfortunately, only Fastcase and Casemaker responded. Neither Lexis nor Westlaw responded. Committee members obtained temporary passwords and tried each product. The committee voted was five to one to recommend Fastcase to the Board for approval. The Board of Trustees approved the recommendation and we're in negotiations with Fastcase. We'll present a package to the Board for funding approval in December. As soon as next year, this could be available to all practitioners.

September 30: Meet Montana ALA Group

Chris Manos, the State Bar's Executive Director and I called on the Montana Chapter of Association of Legal Administrators in Great Falls. These folks (professionals, but not attorneys) manage large law firms. Pretty smart folk! They

invited us to discuss the legal research task force recommendation and how Fastcase may be making its way into Montana. They asked other questions on technology, trust accounts & time keeping. Made some new friends! They'll be supportive in promoting next year's annual convention.
